#### Description

Section I. Invitation to Bid

#### INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF VARIOUS ICT EQUIPMENT AND SOFTWARE

1) The National Meat Inspection Service (NMIS) through the GAA CY 2026 intends to apply the sum of Eight Million Three Hundred Eighty-Six Thousand Five Hundred Pesos (Php8,386,500.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of Various ICT Equipment and Software. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2) The National Meat Inspection Service (NMIS) now invites bids for Supply and Delivery of Various ICT Equipment and Software. Delivery of the Goods is required within Ninety (90) calendar days upon receipt of Notice to Proceed (NTP). Bidders should have completed, at least three (3) years from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3) Bidding will be conducted through competitive bidding procedures. The preliminary examination of bids shall be conducted using a non-discretionary "pass/fail" criterion as specified in Section 59 of the Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 12009. The award shall be given to the bidder with the Lowest Calculated Responsive Bid (LCRB) following the procedures under Sections 61 and 63 of the same IRR.

i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens,

pursuant to RA No. 5183.

4) Interested Bidders may obtain further information from the National Meat Inspection Service (NMIS) and inspect the Bidding Documents at the address given below during 8:00AM-5:00PM, Mondays to Fridays.

5) A complete set of Bidding Documents may be acquired by interested Bidders on 14 January 2026 from the address given below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, details as follows:

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6) The National Meat Inspection Service will hold a Pre-Bid Conference on 21 January 2026; 9:30 AM at NMIS Conference Room, No. 4 Visayas Avenue Brgy. Vasra Quezon City and/or through video conferencing via google meet, which shall be open to prospective Bidders.

7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the office address indicated below on or before 02 February 2026 at 9:00 AM. Late bids shall not be accepted.

8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.

9) Bid opening shall be on 02 February 2026, 9:00 AM at NMIS Conference Room, No. 4 Visayas Avenue Brgy Vasra Quezon City and/or via Google Meet. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.

10) In the event that there will be work disruption on the scheduled date for pre-bid conference, last day of acquisition of bid documents and payment of the cost of bidding documents, bid submission, and opening of bids, the affected procurement activity shall be automatically rescheduled to the next immediately succeeding working day at the same time and venue.

11) In case of a tie or when two or more of the bidders have been post-qualified as lowest calculated and responsive bid, the winning bidder shall be determined through the drawing of lots.

14) The National Meat Inspection Service reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70 of R.A. No. 12009, without incurring any liability to the affected Bidder or Bidders.
